from the Prez

Advisory Board Meeting The Advisory Board selected a a committee to review the Two Forks Dam proposals and they will write up comments on the plan. The committee members are Marcia Tate, Bill Harris, and Larry Riggs. Reports were given on the archaeological work going on in all of the regional areas of Colorado. There is a lot of work going on out there! A letter has been written to the Colorado History Museum to request donations of projectile points for the Colorado Projectile Point Type Collection. CAS decided on the nominees for our representatives to the Board of the Historical Society. We provide them with five candidates from which they will choose two board members. The nominees are Sue Ooton, Steve Sigstad, Marcia Tate, Frank Eddy, and Frank Adkins. We were also given the information on the Hovenweep General Management Plan, the period for public comment is open until May 5th. We have written a chapter letter to the Superintendent of Mesa Verde. The letter was available for signing at the April meeting and has already been sent so that it would meet the deadline.

CAS Board Meeting Due to spiraling costs, it has been suggested that CAS may be forced to increase dues, by five dollars in each category. Several options were looked at to avoid raising dues. It was decided to raise the price of institutional dues, and to list with a subscription service to increase the number of institutional members. It is hoped that this will bring in enough money to avoid raising the dues for members. Two Co-Directors of the Ann Sands Bone Lab were appointed they are Charlotte Brectal and Kathryn Bryant. I was appointed as Technical Advisor. We will be developing the policies for the use of the bone lab this summer. The video "Thieves of Time" was sent to us at no cost by the producers of the video. Each chapter will receive a copy to use as an educational tool.

Field Report We have a new field director! Bob Mutaw, another professional archaeologist / physical anthropologist has agreed to help us this season with our survey projects. We had our first frozen day out in the field on April 23 rd. We located a historic homestead complete with a house foundation, garden, storage sheds and out house pits! The Library really hit the jackpot this last month as you can see from all the new titles. From a donor who chose to remain anonymous we received three non-technical and highly readable books: The Storytelling Stone: Myths and Tales of the American Indians by Susan Feldmann, People of the Deer by Farley Mowat, and God is Red by Vine Deloria, Jr.. From the Alaska BLM we got a big box with the following; Alaska's Cultural Resources: A Cultural Handbook for Alaskans by Raymond C. Leicht, Eagle—Fort Egbert: A Remnant of the Past, The Best Days are Gone: A Visit to Alaskas Forty Mile by Terry Haynes, They Didn't Come in Four-Wheel Drives: An Introduction to Forty Mile History by Terry

Haynes, Nineteen Times Water: Entry to the Forty Mile by Patricia Quehrn, Historical Aspects of the Building of the Washington D.C. - Alaska Military Cable and Telegraph System, with Special Emphasis on the Eagle-Valdez and Goodpaster Telegraph Lines 1902-1903 by William A Quirk III, and Fort Egbert and the Eagle Historic District: Results of Archaeological and Historic research by Shinkwin, Andrews, Sackett and Kroul. From the Montana BLM we received Vol.1 of their Cultural Resource Series, An Overview of the Prehistory of Western and Central North Dakota by Micheal Gregg. We'd like to thank both the Alaska and Montana Bureaus for their help in developing our sets of Cultural Resource books.

From the U.S.D.A Forest Service office in Albuquerque, N.M. we received another major acquisition. Vandalism of Cultural Resources, The Growing Threat to Our Nation's Heritage compiled by Green and Leblanc, Sampling in Cultural Resources Management by DeBloois, Green, Plog and Wood, Symposium on Dynamics of Cultural Resource Management edited by Matheny and Berge, The Wilderness and Cultural Resources Overview: Little Colorado Area, Arizona, Plog, Cultural Resources Management Report No. 2: High Altitude Adaptations in the Southwest edited by Winter, Cultural Resources Management Report No. 5: Stage I Site Locational Modeling in the Southwestern Region edited by Cordell and Green, The Forest Service and the Civilian Conservation Corps: 1933-42 by Otis, Honey, Hogg, and Lakin, and the same office sent us copies of their "Regional C.R. Update— Information on Cultural Resources Management" Nos. 1 through 53 (Aug. 1980 to Dec. 1987). These are valuable additions to the library and we are indeed grateful to have them. Sorry that the limited space forbade the inclusion of the full author's names.

Lastly, from Aaron D. Riggs of Midland, Texas we received the Transactions of both the 21st and 22nd Regional Symposia for Southeastern New Mexico and Western Texas. The library already had the Transactions for the symposia one through nine, so this is a most welcome addition. The librarian has some of the intervening volumes if anyone is interested. This is a very important area for North American archaeology (Blackwater Draw, Clovis, Alibates, Midland, Lubbock Lake are just a few of the major sites in the area) and there is a strong and active group of avocational and professional archaeologists in the area.

It has been quite a month for the library, things from Alaska to Texas with lots in between. Our sincere thanks to all the contributors.








Desert Wind




