

COMMENT LETTERS TO FOREST SERVICE NEEDED

The Arapahoe-Roosevelt National forest is currently in the process of revising its 10 year Forest Plan.

The Arapahoe Roosevelt is a treasury of historic and prehistoric archaeological remains. The Indian Peaks Wilderness Area in the Boulder District is especially rich with ancient games drives and associated sites from the last 9,000 years.

The Boulder District, in spite of the impacts of heavy recreational use on cultural resources, has only a \$1,200 budget to survey, salvage and protect these sites.

Please write the Boulder District Ranger: Michelle Nolde, Boulder District Ranger, Arap/Roos National Forest, 2995 Baseline Road, Room 110, Boulder, CD 80303. Request that your comments be included in the record for consideration in the Forest Plan. Ask that budget and staff be allocated to accomplish the following:

- Perform preemptive, detailed archaeological surveys on <u>all</u> projects to be undertaken in the Arapahoe Roosevelt. These surveys should be supervised only by qualified professionals.
- Immediately undertake salvage archaeological work on those sites that are presently being impacted, i.e., Site 5BL82, an important Mt Albion Complex campsite in the Middle St Vrain Valley which is being impacted by vehicular traffic; Site 5BL73, in the Coney Lake Valley, and site 5BL153 in the Fourth of July Valley which are being damaged by foot and horse traffic (sites are exposed in the trail at both sites). This is work required by the NHPA Law.
- Take a pro-active initiative to explore, investigate and interpret the rich archaeological record in the Boulder District, and other districts of the Arapahoe Roosevelt.

Be sure to mention that you're a member of CAS, that we provide qualified avocationals to assist in cultural resource related activities, and that you appreciate the Forest Service's financial help on the "High Altitude Archaeology Exhibit" built by CAS volunteers in 1991.

Forest Plans are under revision, so if you know folks in other CAS chapters, ask them to write their local forest about protecting cultural resources.

GRANTS PROGRAM FROM GAMING FUNDS

The Society's Office of Archaeology and Historic

Preservation (OAHP) is attempting to find out who may be applying

for historic preservation grants from the new fund created from

the state's revenues from limited gaming.

Grant funds will be available beginning in the summer of 1992 for a wide variety of projects involving historic or archaeological sites. Grants can be made to both public and private entities, including business or individuals. The exact amount of funds available is unknown at the present time; however, the initial projection is around \$750,000.

Anyone who may be interested in applying for a grant either next year or in future years is encouraged to contact DAHP to request a copy of the questionnaire that is being mailed to potential applicants.
