

STONE CIRCLE FIELD TRIP

We thought there would be a problem with attendance at our regular meeting on November 25th, the day before Thanksgiving, so the Executive Board came up with a field trip on the Saturday after Thanksgiving, November 28th.

Local historian and IPCAS member Doc Teegarden will lead a trip to a stone circle site on City of Boulder Open Space. Accompanying us will be David Tucker, a CU graduate student and plains archaeology veteran, who will give us an overview of some of the surprising current research on the enigmatic stone circles.

It has been taken for granted that the circles are products of protohistoric tribes who used the stones to weight down the edges of the large hide covers of their tepees which were transported by their horses. However, recent carbon dating on large stone circles has shown that some may be Archaic in origin, raising questions of how the early nomadic people without horses, transported the hides and other structural components of these habitations; if in fact hides were used; if in fact they were habitations. If they were habitations, what form did they take on and how were the stones used in association with them?

Meet at 10:00 A.M. at the Flatirons Vista trailhead, 2.2 miles south of Eldorado Canyon Dr. (Hwy 170) on the west side of Highway 93. It's a flat walk of 1/2 mile to the site. Wear good boots, bring lunch, water and dress for the cold. Dogs on leashes only please! For more information and sigh-up call Steve Montgomery, 443-4416.

THE NIST CONTROVERSY

You may have been following news stories about the controversial expansion of the NIST Federal Center at 325 South Broadway. General Services Administration, a federal building agency, planned to construct a 236,500 sq. ft. building adjacent to the existing NIST complex. There had been resistance to the plan by neighborhood and conservationist organizations.

In April, 1992, IPCAS received a report of rock piles that might have archaeological significance on the NIST property. We wrote a letter to the State Historic Preservation Officer (SHPO) calling attention to the possible site. The preliminary report of a recent professional survey ordered by GSA (in response to the SHPO's directives) attributed no archaeological significance to the rock piles, however native American groups claim that one of them is the hub of a medicine wheel with spokes pointing to remote sites sacred to the Northern Arapaho and Cheyenne. The presence of a sacred site could effect the building project, as could other efforts aimed at stopping the construction. The issue has become highly politicized.

The IPCAS executive board decided that, aside from alerting the SHPO about the possible site, we would not take an active role in the controversy. If you care to comment, send a letter to GSA at the Denver Federal Center, PO Box 25546, Denver 80225 / Attn. Sharon Malloy before November 30.


