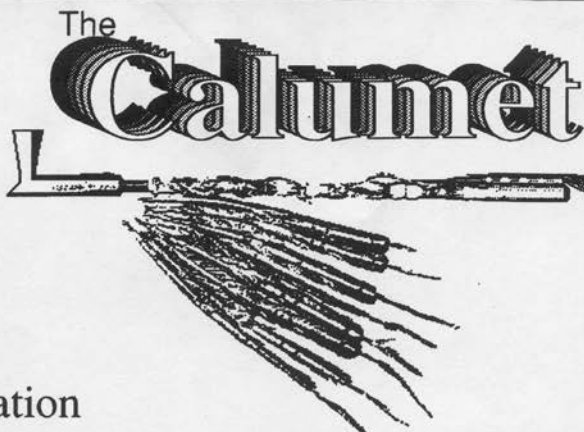

I was privileged to be present at the Feb 19th hearing of the State Register Review Board when Rick Lippincott, on behalf of IPCAS, nominated the Rock Creek site for the State Register of Historic Places. The proposal was defended by archaeologist Peter Gleichman, principle investigator for the project. Our State Historic Preservation Officer, Susan Collins, praised the Rock Creek project as exemplary of cooperation between county government, CAS, avocational, and professional volunteers. The good news is that the Review Board voted to place the Boulder County site on the register! This is a pre-requisite for our application to the Colorado Historic Fund (CHS) for funds to complete the work at Rock Creek. That weighty application is due March 1. We will hear at the end of May whether the CHS grant comes through. If awarded, it will support completion of excavation of both the early ceramic and archaic components of the site. This will give the chapter and other volunteers a fascinating project for the season ahead.



Other field projects are being planned. In June, IPCAS will survey the Andreas Site, a multi-component site on private land in Lefthand Canyon. Excavation of more hearths on Arapahoe Pass under the direction of Jim Benedict will take place early in July. The Denver chapter has invited us to assist in the work at the Swallow site. An organized field trip to the site (on Martin-Marietta property in south Denver) will take place in May. Watch our calendar page for listings. Meanwhile, don't miss Bill Hammond's talk on the Swallow site at our monthly meeting on Tuesday, April 27.

The PAAC class on Perishable Materials, taught by Kevin Black, Assistant State Archaeologist, will be held at the Foothills Nature Center in April and May. The class teaches recognition of culturally-altered floral and faunal materials, their uses, and methods of preservation. Kevin's classes are always fascinating, and you have a chance to complete a requirement toward Surveyor I certification.

Does anyone have problems completing site report forms? Kevin is offering a special workshop for IPCAS members with report-writing blues. It takes place on April 13th, 4 to 7 PM, before the second PAAC class. Join the fun.

NO GENERAL MEETING IN MARCH 1993

The next general meeting of IPCAS will be on **APRIL 27th (4th Tuesday)**, at 7:30 pm, at the Foothills Nature Center, 4201 N. Broadway, Boulder.

Bill Hammond, of the Denver CAS chapter will be our April speaker. Bill will discuss and show slides of the **Swallow Site (5JF321)**. This is a multi-component (Middle & Late Archaic, Ceramic, Historic) site located on Ken-Caryl Ranch. It has been a primary project of excavation and analysis by the Denver Chapter since its first testing in 1983. Bill has supervised the project since 1990.

Denver CAS will open the Swallow Site again this summer. This could provide an opportunity for an Indian Peaks field trip to observe and participate in the excavation. Bill anticipates that another several years of work will be required to complete the project.

Denver CAS operations at the Swallow Site are an outstanding example of avocationalists at work in the field, in lab analysis, and in technical report writing; and is a model we hope we may soon emulate if our application for funding of Rock Creek is approved.

HECKENDORF WILDLIFE AREA PAAC SURVEY

SUMMARY OF JANUARY 20, MEETING.

Treasurer's report: Operating expenses have exceeded income during the past year. An attempt will be made to decrease the cost of rental for meetings and PAAC classes and to modify the newsletter format. Consideration will also be given to asking for membership donations for programs.

President's report: Indian Peaks was asked to host the annual CAS meeting. Decision was made to decline because chapter sponsored the quarterly meeting and co-hosted a reception for the Colorado Professional Archaeologists in 1992.

To decrease costs the Executive Board meetings will be rotated each month to one of the member's home.

OLD BUSINESS: Rick Lippincott will present the rock creek site nomination on February 19.

NEW BUSINESS: Dock Teegarden reported that we have been requested to survey a privately owned ranch, the Andreas property.

SUMMARY OF FEBRUARY 16, MEETING.

Treasurer's report: Expenditures continue to exceed income. PAAC classes have not been charging enough to cover the cost of meeting places.

President's report: No one in the chapter has been able to accept the IPCAS library (about ten book-sized boxes) which has been in storage for the past two years. The CU Anthropology Library is also currently disposing of the same kind of periodicals and reports however the Anthropology Department at Western State College in Gunnison is now building a library and needs just such materials. The board voted to donate ours to WSC. Professor Mark Stiger of WSC gratefully accepted.

NEW BUSINESS: The board decided that we cannot take on the responsibility of surveying the Andreas property until the paperwork for past projects has been submitted and accepted.

OLD BUSINESS: Rick Lippincott reported that the Rock Creek grant application is in process. The board approved paying the Chapter CAS representative registration fees and milage at the rate of \$.20 per mile. Bob Powell has agreed to serve as the CAS Representative.

PAAC CLASSES

What is PAAC, what do the initials mean? These are a series of mini courses that lead to CAS certification.

The Program for Avocational Archaeological Certification, (PAAC), is designed to be a mutually beneficial educational program for avocational and professional archaeologists. It was established in 1978 by CAS and Office of the State Archaeologists of Colorado, (OSAC). It provides a means for CAS members to obtain formally recognized levels of expertise outside of an academic degree program. It also facilitates contributions by avocationalists to public service and assistance in education, government management of cultural resources, research, and protection of archaeological resources in Colorado.

Courses are taught by Kevin Black, Assistant State Archaeologist. Besides Boulder, Kevin teaches in Denver, Ft Collins, Colorado Springs, Pueblo, Carbondale, Del Norte, and Cortez. This is why courses are only offered every six months in Boulder.

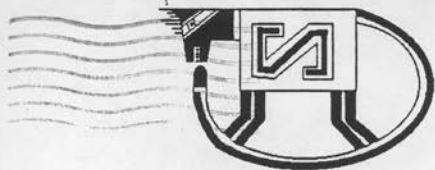
