Modification to IPCAS Bylaws

The Executive Board is requesting a minor change in the IPCAS Bylaws (Revised May, 1992), to amend ARTICLE VI. MEETINGS A.

The current reading is: "The regular meeting of the Chapter shall be held on the fourth Wednesday of each month, unless authorized by the Executive Board". This bylaw would be amended with the following wording:

"The regular meeting of the Chapter shall be held on the second Thursday of each month from September through May, unless authorized by the Executive Board".

Bylaws may be amended by a majority vote of the members present at any regular chapter meeting, with proposed changes being published prior to the meeting in the Chapter newsletter to the membership.

A vote will be taken at the March meeting to amend this bylaw.

QUARTERLY REPORT TO THE COLORAOO ARCHAEOLOGICAL SOCIETY

I. Staffing.

The Office of Archaeology and Historic Preservation (OAHP) is now fully staffed. Among our more recently hired archaeologists is Anne Winslow, a Denver chapter member and chapter PAAC representative.

II. Compliance projects.

OAHP comments on approximately 2,000 federal and state projects each year. One of the more controversial projects in recent years is the plan to widen Interstate 70 between Golden and Glenwood Springs. Local concerns about effects on the historic communities of Georgetown, Silver Plume, Idaho Springs and Glenwood Springs have resulted in CDOT agreeing to reconsider how transportation needs might be met in this Mountain Corridor.

We continue to work with the Bureau of Reclamation to promote reconsideration of project effects for existing reservoirs. One reservoir being resurveyed is Pueblo Reservoir. CAS volunteers have been involved in this survey.

III. Colorado Historical Society administration.

As one of seven division directors in the Colorado Historical Society, I continue to work intensively with my colleagues on daily management concerns. Our President and State Historic Preservation Officer has announced her retirement effective May 3.

IV. Strategic plan.

We continue to review activities and accomplishments. The Office of Archaeology and Historic Preservation has several major areas of focus:

- Public education and outreach
- Maintenance and enhancement of archaeological and historical survey records.
- These records are now being entered into a Geographic Information System, and entry of legacy data is roughly 80% complete. This is currently being accomplished with special federal contracts from the Department of Interior and the State Historical Fund, although federal funds have been diminishing.
- Governmental review functions, including the issuance of archaeological and paleontological permits. We are now corresponding with 2006 permit holders regarding their required end-of-year reports and renewal processes.

V. Unmarked Human Graves procedures.

The Colorado Historical Society continues to work to reconcile our state procedures with tribal expectations. A protocol for how to handle inadvertent discoveries of human remains which are Native American, but for which cultural (tribal) affiliation cannot be established, has been endorsed by 37 tribes. It has been officially accepted by the national Native American Graves Protection and Repatriation Act (NAGPRA) Review Committee and the Secretary Of Interior, pending formal comment by two additional tribes (Jicarilla Apache and Kiowa).

REPORT OF THE LONG RANGE PLANNING COMMITTEE JANUARY 20, 2007

This report is based on the 61 responses we received to the CAS Long Range Planning Questionnaire.

1. If someone asked you, "What is CAS?", how would you reply?

Since archaeology is a science, perhaps it shouldn't be too surprising that 18 of our members responded, quite factually, "Colorado Archaeological Society" and left it at that. Another 17 members saw CAS as an organization. (For example, "a statewide organization that promotes interest, research and protection of archaeology resources in the state." Or "It is an organization interested in all phases of archaeology with membership that varies from the professional to the novice. We have field trips, guest speakers and education opportunities.")

About a third (21) described CAS as a group of people. ("A group of folks interested in the preservation of the past and learning about the past and having fun all at the same time." Or "It's an eclectic group of people from all walks of life who are interested in archaeology." One writer described that "eclectic group" as "physically old, mentally young," while another, more diplomatically, referred to "people of all ages.")

The remaining responders wrote about CAS's function, as they saw it. (Thus, CAS is an "opportunity to learn and be with other people interested in archaeology." Or "CAS is a way for me to share my interest in archaeology with others and to be personally enriched by the 'extensive experiences of others who hold a similar interest.")

An interesting "curiosity" about the different responses was that, when it came to questions about what CAS was doing right, wrong, or not at all, members who gave the "factual reply" had the least to offer --less than half replied. In contrast, those who saw CAS as people or a group of people, offered ideas and suggestions eighty-five percent (85%) of the time.

2. Why did you join CAS and why do you continue your membership?

The variety of answers is almost as great as their number! A somewhat condensed list:

- An interest in the subject, sometimes extending back into childhood
- My daughter in 5th grade wanted to become an archaeologist and ... Was studying anthropology
- To learn more about prehistoric cultures
- Enjoyment of the activities: classes, lectures, field trips, educational outreach Enjoy the company of other members

- Learning with people I enjoy
- It is a vehicle that gets us outdoors and camping Opportunities to dig and tour and learn
- I have an interest in geology and the history of Colorado Participated in a field trip
- Very fine people
- To take advantage of field trips to locations not available to the general public
- Saw an article about our Chapter in the newspaper Interested in rock art and hoped to learn more
- Camaraderie, friendship and a desire to contribute to the education program
- Involved in a survey
- To learn more about the means of evaluating what one finds on a dig Meeting announcement: "Learn how to make an "atlatl"
- Desire to participate in archaeology
- Joined when I was becoming an archaeologist in graduate school
- Joined as a student to receive Southwestern Lore, keep abreast of society proceedings, and belong to organizations I believe in
- Field trips, contacts, speakers, and friendships Information, classes, friends and speakers Fellowship, knowledge, exploration

- The amateur archaeologist's outlet to learn and explore Learn how to support professionals in their work

3. What attracts people to membership in CAS?

The following list shows that there are a number of things that attract members, which may be grouped into four (4) main categories:

- an interest in some aspect of archaeology;
- a desire to learn more through educational opportunities;
- an appreciation of programs, activities and fellowship with like-minded individuals; and
- an opportunity for direct participation in an archaeological activity, such as a dig.

- Interest in Colorado archaeology/ SW archaeology/ rock art/ history/ archaeology/ Native American artifacts and history/ ancient cultures
- Speakers/ programs/ lectures
- Like minds/ SC1111e interests
- Opportunities/ desire to learn
- Mystery
- Outings/ activities/ field trips/ group activities PAAC/ education
- Participation opportunities/ hands-on opportunities/ service opportunities Gain knowledge of ancient man and sites
- Professional archaeologists need support and manpower; avocational archaeologists need to learn and participate
- Socializing/ camaraderie/ fellowship/fun
- Opportunity to discover new sites/ exploration Access to sites
- Southwestern Lore
- Indiana Jones
- Publicity
- Friend's invitation Entertainment factor

4. What are the greatest benefits of membership?

To a degree, the responses to this question echo those given to Question 3.

- Sharing knowledge/ Learning/ PAAC classes -- thirty-three (33) responses
- Meet! Share with others with similar interests -- thirty-three (33) responses
- Field trips -- twenty-nine (29) responses
- Programs/ Speakers/ Meetings/ Lectures -- fourteen (14) responses
- Hands-on service/ Surveys/ Dig participation -- seven (7) responses '
- Participation in an important cause -- three (3) responses
- Annual meeting -- two (2) responses
- Southwestern Lore -- two (2) responses
- Participation in preservation; Publications; Middle ground between professional and casual interest -- one (1) response each

5. Have you served or do you serve on your Chapter's Board or in some other capacity -- such as on a committee? Why or why not?

Forty (40) respondents answered in the affirmative. Most have served in several positions and for an extended period of time. Of those who have not served, the reasons most often cited were a busy schedule/ lack of time/ health issues, recent membership in CAS, and distance -living remote from meetings or being out of state for much of the year. One member said (s)he wanted to serve but hadn't been asked!

6. What is CAS doing right?

A number of respondents mentioned programs and activities that take place at the Chapter, rather than the State, level. However, almost half of the members cited PAAC/ Classes/ Member education as something CAS is doing right. Sharing information/ Resources/ Publications/ Communication -- with specific references to Southwestern Lore, The Surveyor or the Website -- was mentioned on a third of the questionnaires. The Annual Meeting was named on twenty percent (20%) of the questionnaires. The Alice Hamilton scholarships, Public education, and CAS as a spokesperson for preservation, anti-vandalism, etc. were also mentioned. Three (3) members commented favorably about rotating the location of Quarterly Board Meetings.

- Hands-on classes/ PAAC/ Education -- twenty-six (26) responses
- Sharing information/ Offering resources/ Literature -- twenty-two (22) responses
- Annual Meeting -- eleven (11) responses
- Field trips -- six (6) responses
- Scholarships -- six (6) responses
- Provides a foundation for action/ Preservation -- five (5) responses
- Public education -- five (5) responses
- Interesting meetings -- four (4) responses
- Rotation of Quarterly Meeting sites -- three (3) responses
- Encampment; Lectures; Low cost membership; Opportunities for field work; Fellowship -- one (1) response each
- 7. What is CAS doing wrong and/or not doing that it should?
- 8. Is there something CAS needs to do immediately?
- 9. What can CAS do for you? for your Chapter?

Taking questions 7 through 9 as a group, the number of responses we received was the second-most discouraging aspect of our survey. (The total number of questionnaires returned was the greatest disappointment.) Sixty-one (61) questionnaires times three (3) questions should equal one hundred eighty-three (183) responses. However, once we subtracted eighty-three (83) no-response-at-all's, and thirteen (13) responses such as "relax; don't worry, be happy," "keep doing what you're doing," and "keep up the great work," we were left with just eighty-seven (87) suggestions.

Of course, that's still quite a few! Besides, my friends in Marketing tell me that a one percent (1%) response is average to such a survey, three percent (3%) is very good, and six percent (6%) -- which is what we received from a total membership of approximately one thousand (1,000) -- is excellent.

These responses, together with any other ideas we can glean from extended answers to previous questions, will be the starting point for our committee's work in the coming year.

Need volunteers to set-up and provide refreshments at 8:00am, and afternoon. Kevin Black will teach a one-day version of the *Introduction to Archaeology*, CAS and PAAC course on Sunday, January 21, at The Atrium. Fee is \$12. O'Toole, McComb, and Turner will set-up room, provide refreshments and white board. Have reserved all 2007 meeting dates/Christmas party at The Atrium.
