He had been in good health and was preparing for an archaeological trip to South America next week. He was 63 years old.

Rob was the Founder and Director of the Center for the Study of the First Americans, located at Texas A& M. Professor Mike Waters, the Associate Director, will most likely succeed him as Director.

## **COLORADO ARCHAEOLOGICAL SOCIETY, INC. October 2004 Quarterly Board Meeting Minutes Draft**

Durango, Colorado October 8, 2004

CALL TO ORDER: The October Quarterly Board meeting of the Colorado Archaeological Society was called to order by President Tom Hoff at 7:07 p.m.

ROLL CALL: Chapters represented were Chipeta, Rock Art, Denver, Hisatsinom, Hurst, Indian Peaks, Northern Colorado, Pikes Peak, Roaring Fork, and San Juan Basin.

MINUTES: A few minor corrections were noted. Motion passed (Goering/Sundstrom) to approve the minutes as corrected.

EXECUTIVE SECRETARY (Terry Murphy, written report):

The Great Sand Dunes is now a National Park. CAS will have a representative at the 2005 SAA meeting in Salt Lake City with a couple of papers on PAAC and the Role of Avocational Archaeologists and Professionals. Dr. Dennis Stanford has alerted us to a possible problem with a housekeeping bill introduced in the Senate by Senator Ben Nighthorse Campbell which could seriously impact the NAGPRA law. You can keep apprised on the status of the bill by checking the Library of Congress website at <u>www.thomas.loc.gov</u>. If you have any comments, pass them along to Senator Campbell and Senator Allard. We have had an increase in requests for back issues of SWL. We should consider pushing the CD back issues as Terry would like to get some of these thousands of back issues out of his basement. Lora Van Renselaar offered to take Terry's extra issues. In early September, the Colorado Historical Society's "Old Stories, New Voices" program received several national awards for excellence. This included a \$250,000 grant to expand the program. Plans have started to expand the volunteer group and enlarge the program. As of one week ago, the group will try to establish a separate group such as the "Friends of Old Stories / New Voices" so we can go in for grants and not be dependent on the state agencies. CAS representatives were asked to make their chapter members aware and to volunteer. The camp staff needs to triple for next year. Terry is the contact person for the Education Department at CHS. Bill Hammond stated this is one of the best kept secrets in the State – it is an astonishing program.

#### TREASURER (Larry Evans, written report):

Available cash at the end of this quarter is \$30,296. We expect our cost of the Fall 2004 Southwest Lore to be \$5,000, which will be offset by contributions of about \$2,500 from The Smithsonian Department of Anthropology and Dr. Liz Morris. We paid the CHS \$750 for sponsorship of "Mesa Verde" on the Colorado Orientation Map. As of October 1<sup>st</sup>, we have \$49.50 in the SLW fund to meet winter publication expenses. Motion (Sundstrom / Terri Hoff) to approve Larry's request for board authorization to transfer as needed up to \$2,500 from the Unrestricted Operating Fund to the Southwestern Lore Fund to meet the expense of the Winter 2004 issue. There are no funds to print a winter CAS Newsletter. We would need to transfer money from other funds (it costs \$550 to print and mail). We have no incoming funds for it. The next issue would be the spring issue. We can address this at the January meeting.

#### COMMITTEE REPORTS:

#### MEMBERSHIP (Lora Van Renselaar, written report):

Two institutions have not renewed their memberships. Lora has called them with no response. She asked if she should keep sending SWL to these institutions. Decision was made by Tom Hoff for Lora to write a letter to the Anthropology chairs at these institutions asking if they want to maintain their membership. If no response, Lora will no longer send them the SWL. Joel was thanked for putting data from back issues on CD. Lora brought copies of SWL to sell at the annual meeting tomorrow. Decision was made to sell them for \$10. Lora reported we have a new brochure for CAS. Chapters may use them but they may have to change some numbers on them. Larry Evans will email them out to the chapters. Lora reported CAS currently has 1,061 members. Tom Hoff stated that Colorado Preservation Inc. joined as an individual through the Denver Chapter. The Denver Chapter has a category for "Institutions". Decision was made that Lora will write to CPI and ask what they are doing as they cannot join CAS as an individual.

#### ALICE HAMILTON SCHOLARSHIP FUND (Terri Hoff):

Terri stated tomorrow is the big day for fundraising. Ticket sales were handled at the chapter level. Leftover tickets, stubs and money can be given to Sharon Murphy or Terri Hoff either tonight or tomorrow morning. Tickets will continue to be available tomorrow. Items for the Silent Auction will be accepted tomorrow at 7:30 a.m. We have a donor receipt and a bidding receipt. Fill out the donor receipt when you bring the item. Tomorrow all will get a program with a picture of Yellow Jacket Canyon (1908) which has been donated for the auction. This is the only one available. The NPS doesn't want it sold because the HOPI's object because the petroglyphs are "offensive". Value is hard to estimate since it is the only one in circulation.

#### PAAC (Kevin Black, written report):

In the third quarter of 2004, 4 classes were completed. Six new certificates will be given out at the Annual Meeting. With the completion of the PAAC training survey at the Tomahawk State Wildlife Area in 2003, final report preparation continues. Kevin is working toward finishing the report by the end of this year. A report on the work at Pike's Stockade will be presented at the Annual meeting and lab analyses on the small artifact collection will begin in December. There is a list of 7 dates on the PAAC website for resumption of the PAAC lab project at the Lowry facility in east Denver. The next schedule of PAAC courses is on the horizon and the usual questionnaires will be sent to the PAAC Coordinators later this month.

#### **PUBLICATIONS** :

Southwestern Lore (Kevin Black, written report): The fall 2004 issue of Southwestern Lore has been mailed. This issue is larger as it commemorates the career of retired Boulder professor David Breternitz. This special issue was compiled by Liz Morris and Barbara Breternitz. This issue was made possible by the generous financial contribution of Liz Morris, Dennis Stanford and the Smithsonian Institute. The winter issue will contain a tribute to the late Bill Buckles. We have received more papers for consideration. With regard to Colorado Archaeology: an Annual Publication of Southwestern Lore, one new paper has been received for a future second issue. Kevin attended the Colorado Council of Professional Archaeologists executive committee meeting in June and he brought up the subject of a closer working relationship with CAS. The August issue of the CCPA newsletter included an article encouraging CCPA members to join CAS, SWL backstock information, and a CAS application form.

Advertising (Joel Hurmence): There are no potential advertisers for the SWL. Joel asked everyone to try and generate interest in getting advertisers.

Newsletter (Joel Hurmence): There is no newsletter going out this fall, but maybe next spring. Terri Hoff asked if the newsletter could be used as marketing for scholarship applications. Joel indicated he will have a scholarship announcement in the spring issue. Suggestion was made to use the SWL advertising space for scholarship information. Kevin stated that by the end of October or early November, one page on scholarships could be put in the next issue of SWL. Terri Hoff will update the information and get it to Kevin.

Website (Teresa Weedin): Teresa stated that members need to keep her posted of changes for the website. Tom Hoff asked that chapter representatives look at the website to assure the information for their chapter is correct.

#### ADVISORY BOARD (Terri Hoff): No report.

AWARDS (Bob Mutaw): Four chapter achievement awards will be given out at tomorrow's annual meeting. It was stated that Dick Sundstrom's trowel was broken and he is asking for a replacement. After discussion, Tom Hoff stated that Dick will be given a new trowel at CAS's expense.

WAYS AND MEANS (Joel Hurmence): No report:

STATE ARCHAEOLOGIST (Susan Collins): Susan distributed copies of the 2003-04 Annual report of the Colorado Historical Society. She discussed the recent funding mix for the Society, which is supported by diverse revenue streams. These include: The State Historical Fund, generated from the state tax on limited stakes gaming. The Historical Society no longer receives funds from the State General Fund, but draws its base support from the SHF, which was created by constitutional amendment to support a grants program for historic preservation. Federal grants. These include the Historic Preservation (HPF) which funds the Office of Archaeology and Historic Preservation, including the Office of State Archaeologist. Other, project specific grants may be awarded by the national Institute for Museum and Library Services, Native American Graves Protection and Repatriation Act program, Save America's Treasures, and the National Endowment for the Humanities.

Membership dues, gifts, and donations. At its 125<sup>th</sup> anniversary, the Colorado Historical Society is a healthy organization, with many programs that emphasize preservation of Colorado's material heritage and active public education. Susan observed that there is great demand on the State Historical Fund. Funding the Society's operations and undertaking major life-safety repairs on the State Capitol building has reduced the amount available for statewide grants. Nevertheless, the statewide demand continues to be high. For the recent October 1 deadline, applications were received totaling approximately \$8 million. This is roughly 4 times the amount available, so the grant program is becoming increasingly competitive.

Bill Hammond stated the Colorado Historical Society was originally chartered by the state assembly and funded by them. But now, CHS is not funded by them, but by gaming money. He stressed that until the legislature does something, this won't change. It is important for Colorado, the Colorado Historical Society and CAS that there be a line of financial support for the State Historical Society from the state.

CAS REPS TO CHS (Bob Mutaw/Bill Hammond): No report.

#### ANTI-VANDALISM TASK FORCE (Terry Murphy):

The Task Force is moving ahead with the program and activities for the Archaeological and Preservation Month 2005. The Task Force would like to work with a theme of "Historic Trails of Colorado". Terry has sent out a call for good quality photographs of historic trails and ideas to CAS and friends. Photos are needed by the end of October. He asked that chapter representatives put a notice in their chapter newsletters and to note that digital is okay if high resolution.

OLD BUSINESS: 2005 Annual Meeting (Terry Murphy): Terry has been working with the NPS and the Great Sand Dunes Staff on a Symposium in 2005 which would be held in conjunction with the CAS Annual Meeting. The target dates are October 7, 8, and 9 (Friday, Saturday, Sunday) 2005. The proposed theme for the symposium would be the San Luis Valley Area, although the definition is not cast in stone yet. Friday would probably be devoted to geology and biology topics, with Saturday used for archaeology and history topics. Sunday would feature field trips. The site of the symposium / annual meeting would be the Carson Auditorium on the Adams State College campus in Alamosa. At this time, it looks like the only cost to CAS members would be the Friday night dinner/board meeting, a Saturday night banquet and some Sunday field trip expenses. Motel, extra meal and travel costs would be the individual's responsibility.

ROLL CALL: Chapters represented were Chipeta, Rock Art, Denver, Hisatsinom, Hurst, Indian Peaks, Northern Colorado, Pikes Peak, Roaring Fork, and San Juan Basin.

MINUTES: The minutes of the 2003 Annual meeting were previously approved by the Board at its January 2004 meeting.

#### EXECUTIVE SECRETARY (Terry Murphy):

Terry has been working with the NPS and the Great Sand Dunes Staff on a Symposium in 2005 which would be held in conjunction with the CAS Annual Meeting. The target dates are October 7, 8, and 9 (Friday, Saturday, Sunday) 2005. The proposed theme for the symposium would be the San Luis Valley Area, although the definition is not cast in stone yet. Friday would probably be devoted to geology and biology topics, with Saturday used for archaeology and history topics. Sunday would feature field trips. CAS purchased "Mesa Verde" on the Colorado Orientation Map for \$750.

We have two ongoing grants to the Hisatsinom and Denver chapters.

All chapters got new 501c3 letters over the past year so legally you are tax exempt.

The financing of Southwestern Lore is a challenge. We have disks for Southwestern Lore available. June 1955 to Winter 1994 and the Index (PDF). They sell for \$30 each or \$50 for two. Disk one is not ready yet. Disk 4 will be a 10-year issue ready next year. Tom Hoff reported that at last night's Board meeting, the Board approved the transfer of \$2,500 from the Unrestricted Operating Fund to Southwestern Lore Fund to meet the expense of the Winter 2004 issue.

Nevertheless, the statewide demand continues to be high. For the recent October 1 deadline, applications were received totaling approximately \$8 million. This is roughly 4 times the amount available, so the grant program is becoming increasingly competitive.

#### CAS REPS TO CHS (Bob Mutaw/Bill Hammond):

Bob and Bill reported they serve as representatives from CAS to the Colorado Historical Society (CHS) Board. Bill represents the avocational archaeologists; Bob represents the professional archaeologists. If there are any issues for CHS, they will bring to the attention of CHS. Bill commented that having the State Historical Society not funded by the taxpayers is not viable.

#### ANTI-VANDALISM TASK FORCE (Terry Murphy):

Terry stated the Task Force is a group of state and federal officers from NPS, BLM, CCPA and CAS. The group meets monthly. The Task Force is moving ahead with activities for the Archaeological and Preservation Month 2005. The Task Force would like to work with a theme of "Historic Trails of Colorado". Terry has sent out a call for good quality photographs of historic trails. Photos are needed by the end of October. Contact Terry for more information.
